Dear Governor Cuomo,

I am one of almost 5,000 Licensed Acupuncturists in New York State. Every day I see evidence of the opioid crisis amongst my patients. I commend your efforts to fight this epidemic and urge you to continue finding new ways to do so.

Signing this bill is one more way to help end this crisis. A.2023-A / S.6666 dramatically improves access to Acupuncture - an effective, non-drug pain treatment - through New York's Workers' Compensation System. The best way to help people avoid addiction to painkillers is to keep them off drugs in the first place, and acupuncture can help. In August 2017, The Joint Commission, an independent, not-for-profit organization that accredits and certifies nearly 21,000 health care organizations and programs in the United States, recommended in its R3 Report that hospitals consider non-pharmacologic modalities as a complementary approach for pain management that may reduce the need for opioid medications. Acupuncture is one such modality and Licensed Acupuncturists are the most qualified professionals to perform this therapy.

My colleagues and I work diligently to develop strong, compassionate relationships with our patients to provide well-informed care that reduces pain and improves overall wellness. However, a legal loophole and misinformation about cost has continued to keep Licensed Acupuncturists out of NYS Workers' Compensation System in a clearly discriminatory fashion. I urge you to sign this bill to finally allow myself and other NYS Licensed Acupuncturists - expert pain and addiction management professionals - to fully join the fight against opioid addiction.
